<b>Section 4. First-aid measures</b>	
<b>Inhalation</b>	IF INHALED: Remove person to fresh air and keep comfortable for breathing. Call a doctor if you feel unwell.
<b>Ingestion</b>	IF SWALLOWED: Immediately call a doctor. DO NOT INDUCE VOMITING. NEVER give anything by mouth if victim is rapidly losing consciousness, or is unconscious or convulsing. Ventilate area of release. Stop the leak if it can be done safely. <b>Section 7. Handling and storage</b>	
<b>Precautions for safe handling</b>	
Wear protective gloves/ protective clothing/ eye protection/ face protection. Protect from sunlight. Do not expose to temperatures exceeding 50 °C/122 °F. Keep away from heat/sparks/open flames/hot surfaces. - No smoking. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Use only outdoors or in a well-ventilated area. Before handling, it is very important that engineering controls are operating, and that protective equipment requirements and personal hygiene measures are being followed. People working with this chemical should be properly trained regarding its hazards and its safe use. Inspect containers for leaks before handling. Label containers appropriately. Ensure proper ventilation. Do not breathe dust/fume/gas/mist/vapours/spray. Avoid contact with eyes, skin and clothing. Keep away from heat, sparks and flame. Store in a well-ventilated place. Keep container tightly closed. Keep cool. Store locked up. Store away from incompatible materials (Section 10). Inspect all incoming containers to make sure they are properly labelled and not damaged. Storage area should be clearly identified, clear of obstruction and accessible only to trained personnel. Inspect periodically for damage or leaks.
